#### FEMA Disaster Survivor Assistance Teams are

engaging with survivors today in the following counties:

Ashe, Avery, Buncombe, Burke, Caldwell, Haywood, Henderson, Jackson, Macon, Madison, McDowell, Mecklenburg, Mitchell, Polk, Rutherford, Swain, Transylvania, Watauga and Yancey.

These teams may be going door-to-door in communities or be stationed at a convenient location in the community such as a grocery store, school or park. Team members can help residents apply for federal assistance and assess other disaster needs.

## Two Disaster Recovery Centers Now Open



Two Disaster Recovery Centers have opened in Buncombe and McDowell counties to help North Carolinians in disaster affected counties.

The Buncombe County center is located at:

• A.C. Reynolds High School, 1 Rocket Dr., in Asheville, NC 28803. This center is open 8 a.m. - 7 p.m., Monday through Sunday.

The McDowell County DRC is located at:

 McDowell County Senior Center, 100 Spaulding Rd., Marion, NC 28752. This center is open: 8 a.m. - 7 p.m., Monday through Sunday.

A Disaster Recovery Center is a one-stop shop where survivors can receive in-person help as they navigate their recovery process. More centers will be opening soon. Survivors may visit any open recovery center—even if it's located in another state. Find a center nearest you at <u>FEMA.gov/drc</u>.

# **Ongoing Response**

FEMA has approved **\$78 million** in housing and other types of assistance for more than **62,000** households. FEMA is also directly paying hotels for emergency sheltering for more than **1,250** households through FEMA's Transitional Sheltering Assistance.



Sixteen shelters are housing approximately 700 occupants. Mass feeding sites are delivering meals to approximately 24 mobile sites across nine counties. FEMA has provided more than 7.8 million meals and 10 million liters of water to the state.

Search and rescue operations are ongoing in western North Carolina.

FEMA is coordinating with **North Carolina Department of Transportation** and **Federal Highway Administration** on roadway and bridge assessments and our approach to expedite repairs.

Approximately **98,000** customer power outages reported, concentrated in western North Carolina. Cellular restoration continues to improve, with nearly **90%** of cellular sites in service as of today. Only one county (Yancey) remains with **50%** or more cell sites down.

## Apply for FEMA Assistance: Online is the Fastest Option

Homeowners and renters in <u>27 North Carolina counties and tribal members of the Eastern Band of Cherokee</u> <u>Indians</u> can apply for federal assistance in several ways:

- The fastest options are to go online to DisasterAssistance.gov or
- Use the FEMA App.
- You may also call **800-621-3362** any day of the week. If you use a relay service, such as Video Relay Service (VRS), captioned telephone or other service, give FEMA your number for that service.

After you apply, you will be contacted by a FEMA inspector to schedule an appointment. Be sure to answer the phone. The inspector's phone number may be from out of state or show up on caller ID as "unavailable."

#### **Even More Resources Available**

**Disaster Unemployment Assistance (DUA) benefits** are now available in designated counties. File an application for Disaster Unemployment Assistance at <u>des.nc.gov</u>. ## North Carolinians May Be Eligible for Transitional Sheltering in Hotels

North Carolina survivors who cannot return home may be eligible to receive help from FEMA to find a safe and clean place to stay while they make their long-term housing plans. People do not need to request this assistance. FEMA will notify them of their eligibility through an automated phone call, text message, and/or email, depending upon the method of communication they selected at the time of application for disaster assistance.

## Be Alert for Fraud After Tropical Storm Helene in North Carolina

After disasters, con artists and criminals may try to obtain money or steal personal information through fraud or identity theft after Tropical Storm Helene. Note that all FEMA employees wear official photo identification badges and will never charge applicants for disaster assistance. If you believe you are the victim of a scam, report it immediately to your local police or sheriff's department or contact the <u>Office of the Attorney General's Consumer</u> <u>Protection Division</u> or FEMA's Hotline.

#### What Kind of Help Can FEMA Provide?

FEMA assistance does not replace insurance and cannot restore your home to its pre-disaster condition. FEMA may be able to provide help for uninsured or underinsured costs. File your insurance claim, then apply to FEMA. FEMA's disaster assistance offers <u>new benefits</u> for survivors that provide flexible funding, a simplified process and expanded eligibility for access to a wider range of assistance and funds for serious needs.

#### **Questions About Your FEMA Letter**

If you applied for federal assistance after Helene, you will receive an eligibility letter from FEMA in the mail or by email. Read the letter carefully. If you have questions, or disagree with the initial decision, call FEMA at 800-621-3362 to find out what information FEMA needs.

#### **Damaged Wells and Septic Systems**

For private wells and septic systems, FEMA may reimburse you for the cost of a professional, licensed technician to visit your home and prepare an estimate detailing the necessary repairs or replacement of your disaster-damaged systems. FEMA may also pay for the actual repair or replacement cost of your septic system or well, which typically are not covered by homeowner's insurance. At the time of your home inspection, let the FEMA inspector know you have a private well and/or septic system that may have been damaged by the hurricane.

#### Be Safe When Cleaning Up

Follow the direction of local authorities as you clean up. Be aware of safety concerns and separate debris for collection as instructed by local officials. Before cleaning up, make sure to document any property damage with photos and receipts. Use generators only outdoors and at least 20 feet from windows, doors, and attached garages.

Make sure to keep the generator dry and protected from rain or flooding. Residents should not try to clear landslides that are blocking roads without consulting a professional geologist or engineer.

#### **Low-Interest Disaster Loans**

The U.S. Small Business Administration (SBA) offers low-interest disaster loans for homeowners, renters, businesses and nonprofit organizations to cover losses not fully compensated by insurance and other sources. #### **Public Assistance**

State, local, tribal and territorial governments and certain private-non-profit organizations in North Carolina <u>designated counties</u> are eligible for assistance for emergency work and the repair or replacement of disasterdamaged facilities. FEMA provides several options for pass-through entities to disburse grant funds to subrecipients, ensuring flexibility while maintaining compliance with federal regulations.
